The Dog Warden's report for September 2016 was received and placed on file.

The Fire Department Report for September 2016 has not yet been received and has not yet been filed with the Town Clerk.

The Historian's report for September 2016 was received and placed on file.

The Town Court report for September 2016 was received and placed on file.

The Westfield Police report for September 2016 was received and placed on file. Highway:

- The Town Highway Superintendent submitted a written report on activities for September 2016 and highlighted blacktopping, roadside mowing, closing the Barcelona Harbor and fuel usage.

Code Enforcement:

- The Code Enforcement Officer, Bonnie Rae Strickland, submitted a written report highlighting that five permits were issued in the Town for September 2016.
- Fire Inspections are now being added to the work calendar.
- She recently attended a Western Southern Tier Building Officials Conference September 12, 13 and 14, 2016. The conference was dedicated to James Pacanowski for his dedication, knowledge and donation of time and energy to the WSTBOA Educational Committee. James Pacanowski was the prior code enforcement officer for the Town/Village of Westfield and passed away unexpectedly March 4, 2016.

Barcelona Harbor:

- The Pier is closed for the season. The Pier closed September 18, 2016.
- Supervisor Bills and Councilman Herbert commented on the status of the breakwall. A response has been received from the US Army Corps of Engineers to move forward with repairing the breakwall. The timeframe for completion will be approximately six weeks and is weather dependent.

Public Comment:

- Nancy Walker spoke on behalf of the Westfield Ministerial Association. Seven local churches provided dinner for 12 Westfield Police Department Officers in appreciation of their service. The officers were given gift bags, mums and heartfelt appreciation from more than 30 community members. The dinner was served in the North room on 10/5/2016.
- Nancy Walker asked about Bentley Tree Service and whether there was any new information. Supervisor Bills responded that the Town Board is gathering together information to present to the Planning board. Supervisor Martha Bills made the motion to refer the C-M Moratorium, and Solar Moratorium to the Planning board for review and have Attorney Joel Seachrist attend the meeting to present the moratoriums and respond to any questions the planning board members may have. Deputy Supervisor David Brown seconded the motion to forward the moratorium to the Planning Board for review and this was unanimously carried.
- Marion Eno asked the results of the Rt. 5 water district survey and asked what the next step will be. Supervisor Bills responded the responses have been in favor of continuing. The next step is to forward the survey results to the engineers for them to compile and to report back to the board.
- Reporter Rebecca Cuthbert spoke on behalf of members from the community pertaining to the Welch building. What is our plan with the Welch building? Any new businesses interested in renting a space? Have any repairs been done to the building? What is the approximate percentage of occupancy? Supervisor Bills responded that our plan is to develop or sell the building. Some repairs have been done such as, air conditioning and plumbing to get the bathrooms in working order. The approximate occupancy percentage is 40%-50%. Supervisor Bills also thanked Rebecca for attending.

Action of the Board:

To consider the application of Marilynne Northrop for a Special Use Permit to operate a limited retail business involving the sale of farm produce, jams, jellies, roasted coffee, and other value-added items, at 6722 Munson Road, on a parcel designated as tax map Section 226.00, Block 1, Lot 13, and

WHEREAS, Marilynne Northrop (hereinafter, the "Applicant") submitted an application dated August 29, 2016 requesting a Special Use Permit to operate a limited retail business involving the sale of farm produce, jams, jellies, roasted coffee, and other value-added items, at 6722 Munson Road, on a parcel designated as tax map Section 226.00, Block 1, Lot 13,

WHEREAS, the issue of compliance with the State Environmental Quality Review Act has been thoroughly addressed, and a negative declaration was issued after examination of the record and public hearing, and


WHEREAS, the Town of Westfield Planning Board reviewed the application during a meeting held August 10, 2016 and recommended approval of the application, and

WHEREAS, no referral to Chautauqua County Planning Board pursuant to Section 239-m of the General Municipal Law was required for the application, and

WHEREAS, the Town Board has considered all the facts and papers before it, and has heard those wishing to be heard at a public hearing held October 5, 2016 on the application, and finds ample justification to approve the application subject to the qualifications hereinafter set forth

NOW, THEREFORE, BE IT RESOLVED, that the application be and hereby is authorized and approved subject to the conditions and requirements hereinafter set out:

- 1. The Applicant shall undertake the project in accordance with the plans submitted to the Town with the application, and agrees to be bound by the terms of the application, the site plan, and the conditions of this permit.
- 2. This permit shall not be assigned or transferred, in whole or in part, without the prior written consent of the Town.
- 3. The permit shall not be assigned or transferred, in whole or in part, without the prior written consent of the Town of Westfield Town Board.
- 4. This permit shall expire automatically if the proposed shop is not operational by October 5, 2017.
- 5. This permit shall become effective after the Applicant approves each and every provision hereof and agrees to be bound by all of the terms herein contained in consideration of the granting of this special permit.
